  - B. Discuss Harris County Coordination and take necessary action;
4. Consider for approval a Resolution Authorizing Intent to Reimburse for engineering cost associated with the design of the surface water treatment plant;
5. Review Operations Report and authorize repairs;
6. Discuss District matters including, but not limited to authorizing service terminations on delinquent accounts, District activities and staffing, and customer concerns and take necessary action;
