3. Discuss prioritization of M&O and Capital Improvement projects and take any necessary action;
4. Discuss tax exemption for individuals over 65 years of age or disabled and take any necessary action;
5. Discuss Implementation Fee and take any necessary action;
6. Review Bookkeeper's Report, authorize payment of bills and review Investment Report and budget;
7. Consider for approval June 17th through June 21st as the approved dates of attendance for the AWBD Annual Conference;
8. Consider for approval and ratification attendance at the Rual Water Conference and March 25th through March 27th as the approved dates of attendance;
9. Authorize bookkeeper to process payment of bills twice a month;
10. Review Tax Assessor and Collector's Report, and authorize payment of bills;
11. Discuss District matters; including but not limited to, authorizing service terminations on delinquent accounts, discussing delinquent processes; District activities and staffing, and customer concerns;
