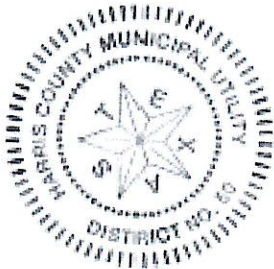
NOTICE

At such meeting, the Board will consider the following:

1. Public Comments (3-minute limit per person);
 2. Approve minutes of meeting held on October 24, 2024;
 3. Renew District Insurance Policy (Expires December 1, 2024);
 4. Indemnification of Directors;
 5. Review Engineer's Report, including, but not limited to approval of plans and specifications, authorize advertisement for bids and/or solicitation of bids, award contracts, approve proposals, approve pay estimates and/or change orders for District projects, and approve capacity commitments;
 - A. Discuss groundwater reduction plan and take necessary action; and
 - B. Discuss Harris County Coordination and take necessary action
 6. Review Operations Report and authorize repairs;
 7. Approve Standard Operating Procedures for District Water/Sewer Line Extension;
 8. Ratify Amendments to the Rate Order;
 9. Discuss District matters including, but not limited to authorizing service terminations on delinquent accounts, District activities and staffing, and customer concerns and take necessary action;
 10. Discuss purchase of real estate;

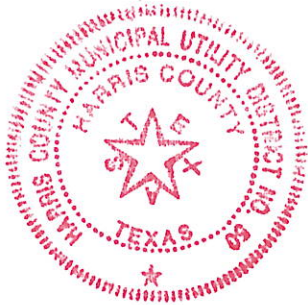
